### **CAMERON PARISH PORT HARBOR & TERMINAL DISTRICT**

**August 28, 2018**

The Cameron Parish Port Harbor & Terminal District met in regular session on Tuesday, August 28, 2018 at the Port Board Building, Cameron, Louisiana at 6:00 o'clock PM.

The meeting was called to order by Chairman Cliff Cabell.

Jimmy Brown led the Pledge of Allegiance and Jimmy Brown gave the invocation.

On the motion of Mr. Dupont, seconded by Mr. Brown and carried the board approved the July 31, 2018 regular meeting minutes.

On the motion of Mr. Trahan, seconded by Mr. Wilkerson and carried the board approved the Treasurer's Report.

On the motion of Mr. Romero, seconded by Mr. Trahan and carried the board gave the President authority to sign and authorize Port Director Clair Hebert Marceaux as designee for Electronic Billing with the Cameron Parish Police Jury for Cornellia Dunaway's salary increase and future salary and Police Jury invoicing.

Director Clair Hebert Marceaux gave a general report on meetings with land owners regarding utilization of their land in projects, Cameron Parish principals, teachers and staff to discuss new S.T. A. R.

Program, Stuart Consulting , Lafarge Holcom, LA wildlife & Fisheries, Matt Redd, Senator Blade Morrish, UL Lafayette's Institute of Water and Coastal Research director, McNeese President, Dr. Darryl Burckel , Duplantis Design Group, attended Venture Global LNG FERC open house, SWLA Regional Business Team meeting, 21018 Lt. Governor's Tourism Summit, August SWLA Economic Development Foundation board meeting, 13<sup>th</sup> Annual Legislator Luncheon, and participated in LIDEA board meeting and the discussion regarding funding for dredging of the Calcasieu Ship Channel with the Port of Lake Charles and channel users. She also updated the board on Commonwealth LNG and Port Cameron. Discussion and Public Comment Period followed.
